

Banks

Banks in Australia are open from 09:30h to 16:00h Monday to Thursday and 09:30h to 17:00h on Fridays. Most banks are closed Saturday and Sunday. Exchange facilities are available at the airport and most major hotels.

The Honourable Chief Justice Tom Bathurst



Thomas Frederick Bathurst was appointed Chief Justice of New South Wales on 1 June 2011. Graduating with degrees in Arts and Law from the University of Sydney in 1971, he went on to practise as a solicitor in 1972. He was admitted as a barrister in 1977, specialising in corporate

law and litigation and was appointed Queen's Counsel in 1987. His considerable experience in corporate law saw his appointment as a member of the Australian Government's Takeovers Panel (2006-2011).

Prior to his appointment to the bench, the Chief Justice served as President of both the Australian Bar Association (2008-2010) and the New South Wales Bar Association (2009-2011

Daniel Fogarty



Daniel has substantial executive experience in the Australian General Insurance market. He joined Zurich in 2009 to manage the SME & Packages business and was promoted to Chief Operating Officer in 2010, then Executive General Manager, Corporate in 2011. In July 2012, he became CEO

GI Australia & New Zealand and was appointed to the Board of the Insurance Council of Australia in February 2013.

Previously he held several Executive General Manager positions in general insurance during his 5½ years at Suncorp/Vero. Prior to that, during 15 years at Westpac, he had a variety of roles, including insurance, international and domestic banking. Daniel started his career at KPMG and is a Chartered Accountant and a Sloan Fellow with a Masters from Stanford University Graduate School of Business, California. He is also a Graduate Member, Australian Institute of Company Directors, a Fellow, Financial Services Institute of Australasia and a member of the Insurance Council of Australia Board.

Dallas Booth






